## MAID chart of legislative requirements for nurses

This chart is an overview of the legislative requirements for medical assistance in dying. An NP can provide an eligible patient with MAID. CNO recognizes that RNs and RPNs play an important role in the MAID process as members of the interprofessional health care team.
